- 2. - 1. RMGL has developed a Metro link from Sikanderpur Station to NH-8, Gurugram (5.1kms). This link is already operational since November, 2013. RMGSL is developing another Metro link from Sikanderpur Station to Sector-56, Gurugram (6.5kms).
- 2. An agenda was placed in the 18th Board meeting of HMRTC held on 02.05.2016 vide agenda item no. 18.11. The abstract of minutes of 18th Board meeting is reproduced hereunder:
 - "A presentation was given by RMGL/RMGSL on the critical issues concerning their projects. Board considered the same and directed MD, HMRTC to examine the same in detail and put up proposal on the file."
- 3. In compliance of above orders, the matter was examined and was forwarded to CCF, HUDA for comments regarding request of RMGL to be a guarantor for raising loan from NCRPB. Based on the comments of CCF, HUDA and other issues raised by RMGL, comments of HMRTC were put up on relevant file to chairman HMRTC. It was decided to place the matter in next Board meeting. c. This request of RMGSL is again against the terms and conditions of concession agreement which can't be considered. However, relaxation, if any, in the terms and conditions of the concession agreement may be considered.

2 TOD operationalisation – creation of Infrastructure development Fund (IDF)

The TOD framework envisages creation of an "Urban Infrastructure Fund" for supporting the development of mass transit corridors. Since Rapid Metro alignments have been developed in the PPP format, an appropriate mechanism needs to be evolved for corridor specific benefits to flow through to Rapid Metro.

The GoH vide notification dated 09.02.2016 has notified TOD policy. The fee/charges collected under this policy shall be kept in the separate head in the `Infrastructure Development Fund' (IDF) and the same shall exclusively be utilized for implementation of MRTS projects. The policy is silent whether Metro projects being implemented under PPP mode can be financed through the IDF.

3 **Viability Gap Funding from GoI**

Support of Govt. of Haryana is solicited in providing assistance for securing viability gap funding from Govt. of India.

Article 9 of the concession agreement entered between HUDA & RMGL on 09.12.2009 deals with Obligations of HUDA. The relevant provision in this case i.e. 9.2 is reproduced hereunder:

The Govt. of Haryana/HUDA will not:

 Provide any financial support in the form of equity or grant during construction of the project or any subsidy during operation and

maintenance of the project.

- 2. Stand guarantee for raising finance during construction and operation.
- 3. Provide exemption from payment of taxes and duties.
- Provide any rebate on electric charges/ water charges etc., consumed during construction and operation.

In view of above provisions of agreement, HUDA/GoH is not bound to consider the request of RMGL. CCF, HUDA has opined that in view of decision of Hon'ble High Court dated 15.12.2015 passed in CWP No. 9558 of 2015, M/s V P N Buildtech Pvt. Ltd. vs. State of Haryana, Metro should not be part of EDC. The Metro funding should be either from IDF or from State Govt.

Advertisement policy of Urban Local Bodies, GoH to be supportive for PPP projects like Metro

It has been apprised that RMGL has already represented to the Govt. of Haryana regarding the draft advertisement policy being proposed Urban Local the Bodies Department Haryana. RMGL has sought exemption from additional levies being imposed on PPP projects, permitted under Section 29 of Metro Railways (Operations and Maintenance) Act, 2002, amended in

The matter basically relates to ULB department. However, the fee prescribed under the Haryana Municipal Act, 1994 can't be waived off. RMGL has already taken up the matter with ULB department vide letter dated 05.10.2016.

5 Integration with comprehensive mobility plan for Gurugram

The National Urban Transport Policy issued by MoUD, GoI contemplates "enabling the establishment of quality focussed multi-modal public transport systems that are well integrated,

The comprehensive mobility plan for Gurugram has already been got finalized by T&CP department. The subject of urban transportation is being dealt by Urban Local Bodies department, Haryana and the concern of RMGL shall be addressed

providing seamless travel across modes", as also envisaged in the MoU dated Dec'11 between MoUD & Govt. of Haryana. It has been requested to consider the following:

- a. Framing an integrated multimodal plan for the metro, City Bus Service & other motorised as well as non-motorised modes in Gurugram expeditiously, with integrated ticketing, for encouraging use of public transport.
- b. Govt. should consider announcing "Green" corridors along Metro alignments & other mass transit routes identified under integrated transportation network.
- c. Parking at each metro station need to be provided to enable "park & ride". In this regard, feasibility of car parks has already been examined in the vicinity of stations & potential locations identified by the local authorities towards which a proposal is currently under consideration by the Govt. of Haryana. A suitable proposal for developing the car parks in mixed use format will be initiated once the allocation of car parks is finalized.

6 Deferment of prescribed charges payable to HUDA

In view of the continuing losses being incurred by Rapid Metro & the mounting accumulated losses, RMGL has requested that land lease charges as well as "non fare" revenue share payable to HUDA be deferred till cash breakeven is achieved by the project.

The request of the RMGL is against the concession agreement and can't be considered.

1. HMRTC is a Joint venture of State Government, HUDA and HSIIDC with following equity contribution:

 State Government 51% - HUDA 29% - HSIIDC 20%

The Authorised share capital of the corporation is Rs.100 crores and Paid up share capital is Rs. 1 crore

2. The funds for Metro projects being executed by DMRC in Haryana are contributed by the State Government and its agencies in the following ratio:-

3. The Board is informed that DMRC has conveyed that Balance of funds (difference of amount released to DMRC & Expenditure incurred by DMRC) is already negative by Rs. 324.32 crores for all three corridors (Badarpur to YMCA Chowk, YMCA Chowk to Ballabhgarh & Mundka to Bahadurgarh) taken together and any further shortfall may adversely affect the progress of work of these Metro Projects. DMRC has demanded Rs. 922.39 crores as per following details:

The Share of cost of Metro link from YMCA Chowk to Ballabhgarh is Rs. 440.23 instead of Rs. 458.80 crore, further Rs. 9.50 crore has been released to DMRC on 19.10.2016, Hence, demand raised by DMRC should be treated as **Rs. 894.32 crore instead of Rs. 922.39 crore**.

- **6.** HMRTC does not have its own source of income and all the funds released by HMRTC to DMRC for execution of projects, are contributed by State Govt. and its agencies. Since, HUDA and HSIIDC are not contributing their share, thus, HMRTC is unable to perform its contractual liabilities towards DMRC.
- **7.** The matter was discussed in the meeting held on 28.10.2016 at 11:30 AM under the chairmanship of Sh. S.S. Prasad, IAS, Additional Chief Secretary to Govt. of Haryana, Town and Country Planning Department which was attended by MD, HSIIDC, DGTCP, CA, HUDA-cum-MD, HMRTC, CCF, HUDA & CTP, HSIIDC wherein it was decided that:
 - a. The contributing agencies for Metro Project may transfer the funds as mentioned above to HMRTC immediately for making payment to DMRC.
 - b. In view of the liquidity crunch in HUDA & HSIIDC, the financing pattern of HMRTC needs to be reviewed. State Govt. may be requested to share 50% cost of Metro

Projects. The remaining 50% cost of Metro Projects should be contributed from IDF. HUDA & HSIIDC may not contribute funds for Metro Projects.

- **8.** Even after above decisions, no funds have been transferred by contributing agency to HMRTC. In compliance of decision mentioned in Para (b) above, a case has already been submitted to the Hon'ble Chief Minister, Haryana on 28.11.2016 to consider the above proposal.
- **9.** Board may take note of the above status and may resolve the funding pattern proposed in para 6(b) above.

Item No 20.10 Public Investment Board (PIB) Note for the extension of Metro Link from YMCA Chowk to Ballabhgarh

1. Board is informed that the matter regarding operational losses was placed before the Board in its 18th meeting held on 02.05.2016 vide agenda item no. 18.6. The following decision was taken by the Board:

"The Board considered and noted the matter. Regarding observation (i) of MOUD, it was resolved that, MoUD may be requested to grant the sanction of the project of Metro extension from YMCA Chowk to Ballabhgarh considering the same provision as approved for the projects of extension of Delhi Metro from Badarpur to YMCA Chowk and from Mundka to Bahadurgarh. In these two projects, the sanction was granted by MoUD with the provision that DMRC will work out what sort of mechanism is feasible for operational profits/losses for a particular line in future. If there is a case of operational losses in future, the Board of Directors of DMRC would consider the issue with specific inputs from the Chief Secretary, GNCTD and Chief Secretary, Haryana".

- 2. Accordingly, MoUD was requested vide letter dated 24.05.2016 (Annexure-V) to grant the sanction of the project on the above said condition. MoUD vide letter dated 1.7.2016 again sent PIB note and reiterated the earlier stand. MoUD was intimated vide letter dated 27.07.2016 that condition "Operational losses, if any shall be shared between GNCTD & GOI in respect of routes within the jurisdiction of Delhi and operational losses in respect of routes within the jurisdiction of States of UP & Haryana should be borne by respective states" is not acceptable to GoH.
- 3. MoUD vide memo no. K-14011/9/2012-MRTS-1 dated 20.09.2016 (Annexure-VI) again requested to accept the condition that operational losses for this line is to be borne by Government of Haryana.
- 4. MOUD was apprised vide letter dated 30.09.2016 that the "Matter will be placed before the Board of HMRTC to take a decision. The same will be intimated to your office accordingly."

Matter is placed before the Board for taking necessary decision.

- 1. The Board in its 7th Meeting held on 11.12.2013 decided to appoint one Advisor (Finance) and skeletal staff on contract basis initially for a period of one year in order to make the corporation functional. The skeletal Staff i.e. one Manager (Technical), one Finance Officer, one Accounts Officer and one Accountant may be appointed through outsourcing on contract basis initially for a period of one year. It was also decided that service of Company Secretary be outsourced to comply with the provisions of Companies Act.
- 2. In pursuance of above decision, one Finance Officer, one Accounts Officer and one Accountant were appointed through outsourcing from M/s P.K. Bhasin & Associates initially for a period of one year w.e.f. 01.03.2014 on monthly fees of Rs. 99000/- per month plus service tax.
- 3. Sh.Girish Madan was appointed as Company Secretary in practice on retainer-ship basis for secretarial work of HMRTC initially for a period of one year w.e.f 01.03.2014 on monthly fees of Rs.7500/- per month plus service tax.
- 4. Sh. Kharaiti Lal, PA (Retd.) was appointed as PA to Advisor (Finance) on the consolidated salary of Rs. 20,000/- p.m.Sh. Akbar, Data Entry Operator was appointed on 04.08.2014 through HARTRON in HMRTC. His present term has expired on 05.08.2016. Managing Director has already approved the extension of the official for one year on the same terms & conditions.
- 5. Board is informed that tenure of service of PA to Advisor (Finance) will expire on 03.02.2017 and the outsourcing contract of M/s P.K. Bhasin & Associates will expire on 28.02.2017. Similarly the outsourcing contract of Company Secretary in practice Sh. Girish Madan will also expire on 28.02.2017.
- 6. There is no regular staff posted in HMRTC and the services of the staff appointed on contract basis are very much required. The Board may grant further extension of contract of above mentioned staff of HMRTC. Board may also grant ex post facto approval of decision of extension of services of DEO.
- 7. Further, Board may authorise MD, HMRTC to give all such extensions at his level.

Board is hereby informed that in pursuant to Companies Act 2013, the 4th Annual General Meeting of the shareholders of HMRTC was required to be held on or before 30.09.2016. The meeting could not be held within prescribed time due to non availability of financial statements. The draft notice of the meeting is attached at **Annexure-VII**.

Board may note and pass the following resolution:

Institutional Strategy for the construction of Metro Rail projects by HMRTC.

- 1. Board in its 12th meeting held on 30.03.2015 decided that a study may be got conducted to examine the feasibility of Metro Projects being constructed by HMRTC itself, after raising finances from lenders/market. Accordingly, Terms of reference for the study were finalized. The Board in its 15th meeting held on 29.09.2015 decided that DIMTS (lowest bidder) may be appointed as Consultants for conducting the study to examine the institutional strategy for the construction of Metro Rail Projects by HMRTC. The letter of award was given to DIMTS on 21.10.2015. Draft Report was submitted by the consultant on 11.02.2016. A presentation of Draft Report was made by the consultants before the Board of Directors after 19th Board Meeting held on 31.05.2016. The Board considered the report and approved it.
- **2.** The Final Report has been submitted by the consultant on 05.08.2016 in which the consultant has suggested following **options for implementation** of Mass Transit Project in the State.
- a. Development and operations by Government (through project SPVs)
- b. Development of system through Government Agencies and operation by the private sector PPP basis.
- c. Construction and operation by private sector on design, build, finance operate and transfer (DBFOT) basis.
- **3.** The consultant has also suggested following **financing options** for implementation of Metro Projects:

- **4.** The consultant has suggested the following **financing strategies and proposed Organization Structure** for implementation of Metro Projects:
- a. Ring-fencing of resources
- b. Infrastructure development charges
- c. Set up a dedicated state level-Urban Transport Fund (UTF)
 - Overall management of HMRTC shall rests with the Board of Director, its highest decision making body. The day-to-day management of the company will be entrusted with the Managing Director who would be supported by functional department heads and other officers and staff of HMRTC.
- **5.** In order to address the immediate needs/requirements, it has been suggested to have an interim organization set up which could be scaled up according to the future responsibilities and roles that the organization.

A presentation of its Final Report is being made by DIMTS after this Board Meeting.

- 2. On the request of HSIIDC, original share certificates of Rs. 18 lacs have been handed over to the organization.

Advertisement regarding invitation for expression of interest for conducting Techno Feasibility Study for setting up of Multi Modal Transit Centres (MMTCs) at Gurugram, Faridabad, Bahadurgarh & Kundli was published in newspapers on 06.09.2016. Following three bidders have submitted their bids by the closing date of 28.10.2016:

 - (ii) Tata Consulting Engineers Limited.
 - (iii) Delhi Integrated Multi Modal Transit System Limited (DIMTS)

Technical Bids have been opened. Further some clarifications have been sought from the bidders. A committee under the Chairmanship of CCF, HUDA consisting of CE-II, HUDA, Chief Architect, HUDA, Advisor Planning, HMRTC & DA, HUDA as members has been constituted to evaluate the bids.

4. Haryana Bureau of Public enterprises vide U.No. 20/5/2016 Asstt/HBPE(FD) dated 23.11.2016 has conveyed creation of one post of Advisor (Planning) in HMRTC equivalent to the post of Chief Town Planner in HUDA, in the pay scale of Rs. 37,400 - 67,000/-plus Rs. 10,000/-GP and the post should be filled up on deputation from the State, Government Departments/ Organizations from incumbents having 3 years experience as Senior Town Planner.
