1.2 POINTS TO BE NOTED

1.2.1 Works envisaged under this contract are required to be completed in all respects within the period of completion mentioned above.

1.2.2 The mere fact that the tenderer has submitted the tender for the work shall not imply that this tender shall automatically be accepted. The same should contain all technical details as required for the consideration of tender. The agencies qualifying as per eligibility criteria mentioned the Clause 1.2.3 should only quote.

1.2.3 The qualifying criteria is as under :-

- (i) The agency would have successfully completed in the last 5 years (The year ending on the last day of previous month to the month in which the tender is invited) the Geotechnical investigation works as below.
- (a) One similar nature of work of 80% of value i.e. Rs.40.11 Lakhs or more.
or
- (b) Two similar nature of works of 50% of value i.e. Rs.25.07 Lakhs or more.
or
- (c) Three similar nature of works of 40% of value i.e. Rs.20.05 Lakhs or more.

Note: Bidders shall submit the certificate of completion of such works from the clients.

- (ii) The agencies should have the average annual financial turnover during the last three (3) years, ending 31st March of 2023 of at least INR 1.50 Crores. The offer of the agency not qualifying the above criteria will summarily be rejected without assigning any reason.
- (iii) Bidder to qualify should have minimum Four drilling Rigs (Rotary) of his own for which he should submit the documentary proof while submitting his bid on the e-tender portal.
